## Waiver, Release, Hold Harmless and Media Agreement

I release and forever discharge all parties from all such claims.

I agree to indemnify and hold all parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the parties.
4. I have carefully read and reviewed this Waiver, Release And Hold Harmless Agreement. I understand it fully and I execute it voluntarily.
